Dear Customers, Dear Business Partners of Messer CZ s.r.o.,

We are writing to let you know about some partial changes relating to the planned merger of Messer CZ s.r.o. in its capacity as the merged company and Messer Technogas s.r.o. in its capacity as the successor company. The anticipated date of this changes is 1.1.2021. For further details, please visit https://www.messer.cz/messer-cz.

For you, as customers of Messer CZ s.r.o., there will be no major changes on transition to the contractual relationship with Messer Technogas s.r.o. All of the contractual obligations towards you, the customers of Messer, will remain valid.

The method of delivery or collection of products will also be preserved and, as has been the case until now, we will inform you of all partial changes in advance.

The following changes are concerned at this point in time:

- In view of the fact that we will no longer be able to use the trade names of products by Air Liquide for our deliveries, as of 1.1.2012, Messer Technogas s.r.o. will start to deliver and invoice products under the new trade names and product numbers of Messer. Nothing will change for you from the point of view of product and packaging quality, the change relates only to the names of products. We are also convinced that classification of the names of gases delivered is clearer in our company and, in many cases, references the composition of the delivered gas in a simpler and clearer manner. - At the same time, due to the simpler structure of prices in Messer, certain products will be merged which will also lead to certain prices or fees being merged. Of course, in a manner which does not affect the resulting final price.
- Another change is invoicing of delivered liquid products in units of kg, this
 currently being the standard unit of measure used by suppliers of technical gases.
 Here too, the change will have no impact on the overall current price of delivered
 products.
- In relation to the prepared merger, we kindly ask that you carefully follow the instructions for the bank details on invoices issued after 1.1.2021 and that you remit your payments to the stipulated accounts. Please change any permanent bank details you may have in your systems and remit payments to the account stipulated on the invoices. You can check these accounts of Messer Technogas s.r.o.
